Course of one year duration with an annual intake of 100 (One Hundred Only) students.

- AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Shri Mahaveer Shikshak Prashikshan Mahavidyalaya, Near Railway Station, Kishangarh Renwal, Jaipur (Raj.) for conducting B.Ed. Course of one year duration with an annual 120 intake of 100 (One Hundred Only) students under clause 7(12) of Regulation dated 13.01.2006 subject to fulfillment of the following:
 - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc. wherever
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duty a willed by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section (FCD) of the NCTS ACT.

I am directed to say that SHRI MAHAVEER SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA has applied for grant of recognition / permission for B.ED of 1 years duration to NRC-NCTE under section 14 (1) of the NCTE Act, 1993.

2. The NRC had constituted a Visiting Team to visit the institution, which had visited the institution and have submitted its report. Upon consideration of the report submitted by the visiting team, VCD, Original file of the institution and other materials furnished by the institution alongwith the application by the NRC in its 118 (Ist Sitting) meeting held on 16th-17th June, 2007, the NRC is of the opinion that the institution does not fulfill the norms and standards laid down and notified by the NCTE in accordance with the provisions of the NCTE Act, 1993 and other requirements, the details of which are mentioned below :-

Accommodation for classroom not provided as per NCTE norms The instructional space is not as per NCTE norms. Furmiture not provided adequately in the institution. Facilities for accessing and use of digital learning resources not provided. Access to Internet not provided in the ET Lab. Facilities in the Science lab are not adequately provided.

- 3. Before the NRC passes an order for refusal of recognition to the institution u/s 14 of the NCTE Act, you are hereby given an opportunity under section 14 (3) (b) of the NCTE Act, 1993 for making such written representation as you may wish to make.
- 4. Your written representation alongwith an Affidavit testifying the contents of the reply must reach this office within 30 days of the issue of this Notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the NRC shall take decision under Section 14 (3) (b), as it deems fit and proper.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Loacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for reserve education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Between Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution i.e. Shri Mahaveer Shikshak Prashikshan Mahavidyalaya. Near Railway Station, Kishangarh - Renwal, Jaipur, Rajasthan has been recognized for B.Ed. by NRC vide order No. F.NRC/NCTE/F-7/ RJ-919/2007/23702 dt. 08.08.2007 for an annual intake of 100.
- AND WHEREAS, the institution Shri Mahaveer Shikshak Prashikshan Mahavidyalaya, Near Railway Station, Kishangarh - Renwal, Jaipur, Rajasthan has by affidavit consented to come under New Regulations and sought for two basic units in B. Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution two basic units of 50 students each subject to fulfillment of the following conditions namely.
 - The institution shall create additional facilities which include (a) additional built-up-area. (b) 14) additional infrastructure, (c) additional funds, (d) adherence to staff norms as per Regulations. 2014 and inform the Regional Committees with required documents by October 31, 2015.
 - The applicant Institution, for additional unit will be required to submit the required documents, such as land documents, Non-Encumbrance Certificate (NEC), Land Use Certificate (CLU) and the Building Pian (BP) in the format available on the website, to the Regional Committee in proof of having provided additional facilities, before October 31, 2015, Building Completion Certificate (BCC) may be given along with other documents, if available, otherwise it may be given to the Visiting Team at the time of inspection.
 - The Regional Committée shall arrange for verification of documents, inspection of the premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 (iv) of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending. such institution shall be required to submit the requisite documents as per provisions of the NCTF Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order Shri Mahaveer Shikshak Prashikshan Mahavidyalaya, Near Railway Station, Kishangarh - Renwal, Jaipur, Rajasthan for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein, before 31,10,2015.
